GLOSSARY

SAFE - Systems and Assurance Framework for Eye-health. This provides the core constructs and technical tools for the planning, provision and commissioning of eye health and care service systems.

Service System – includes the range of pathways of care delivering services that may involve multiple providers and settings, to address the needs of a defined patient population or condition.

Portfolio of Indicators for Eye Health and Care - This presents key evidence-based indicators to monitor quality and outcomes from eye health and care services. It includes the metrics for SAFE. They are measurable, reportable, and make better use of existing sources and reporting requirements.
